Numbers under 60 will be allocated a 2 tee start; all numbers over 60 will be a shotgun start with play from holes allocated by the club. The course will still be open to members on days where the number of participants is below 100.

The event of the day will generally be an Ambrose competition with par or Stableford an option for players with registered handicaps.

TERMS AND CONDITIONS

BOOKING

There is a surcharge of \$15.00 per person for bookings on a Sunday. All prices quoted include goods and services tax. An additional quoted surcharge applies to all events booked on any public holiday.

DEPOSIT

All bookings are considered tentative and may be changed or cancelled without notice, until a deposit of \$1000.00 is received. Please ensure that when making arrangements to pay your deposit a copy of the signed contract is accompanying your payment. Once the deposit is received, firm bookings are then made for all arrangements and a confirmation letter forwarded to you.

PAYMENT OF PACKAGE BALANCE

We will send you a tax invoice 7 days after your event. Balance of any monies outstanding is due and payable no later than 7 days after receipt of the invoice. Payment can be made by cash, cheque or direct debit into our bank account. If paying by credit card the merchant service fee of 3% will be charged.

INSURANCE

Our staff will take care of all your needs and endeavour to look after your belongings, however we cannot take responsibility for damage or loss of items before, during or after your group's attendance and we recommend that personal insurance cover be held.

GOLF COURSE ATTIRE

Portsea Golf Club has strict dress regulations - **no denim, running shoes and track suits**. Please ensure your guests are fully advised.

If you are unsure about dress code please contact the Pro Shop for clarification on 5984 2909.

CANCELLATIONS, REDUCTION OF NUMBERS AND REFUNDS

Naturally, we are disappointed if any corporate golf event is cancelled, however we do realise that circumstance sometimes make such action unavoidable. The following conditions apply in regard to deposit refunds.

- If cancellation is 2 months or more prior to the event date – deposit refunded in full less a 25% administration fee.
- If cancellation is 14 days to 2 months prior to the event date – deposit refunded in full less a 40% administration fee.
- If cancellation is less than 14 days prior to the event date – no refund.
- Deposits and final payments may be made by cash, cheque, Visa or MasterCard. Diners and AMEX attract a 3% merchant service fee.

In order to confirm numbers for your event, you must contact our Events Manager at least 7 days prior to your event and let us know if your projected number of players is different from the number of players listed on your agreement form and to confirm the final total. Once numbers are confirmed, no reduction in cost will be given if numbers fall below the confirmed amount. Extremes in climatic conditions are not due cause for loss of numbers or cancellation of booking. Course closure is at the sole discretion of the Golf Superintendent.

GENERAL

The organiser of the booking as noted on the agreement form is responsible for the group at all times. It is their responsibility to inform all people within the group of these conditions and general information. The clubhouse is a non-smoking venue.

House policy for responsible service of alcohol consumption in moderation and by law we will refuse to serve people that seem to be intoxicated. All alcoholic beverages must be purchased only from Portsea Golf Club staff and will be served in open containers.

All Portsea Food & Beverage staff are trained in **The Responsible Servicing Of Alcohol**. They are therefore obligated under State legislation to observe these principles.

Only food and beverages purchased from Portsea Golf Club may be consumed on the property. Our suggested menus are selected from our comprehensive range of food items and we are happy to offer other options to suit your specific requirements should you wish.
